What is MCPA

The Missouri Crime Prevention Association (MCPA) was formed in 1979. The purpose of MCPA is to promote and encourage crime prevention efforts in the State of Missouri, by serving as a resource to law enforcement and community groups for program development and training in crime prevention activities and techniques.

The goal of MCPA is to substantially reduce criminal activity in Missouri through professional crime prevention action with citizen involvement.

Objectives of MCPA include:

- Providing a vehicle for the communication of crime prevention information, activities, programs, projects and techniques between participating agencies and groups,
- Developing or assisting in the development of crime prevention programs and projects that have statewide and local impact,
- Recommending or providing crime prevention instruction upon request,
- Recommending uniformity in program implementation,
- Obtaining funding to accomplish these objectives, and
- Providing valuable, cost-effective, pertinent, POST-certified training to its membership.

Membership Categories
