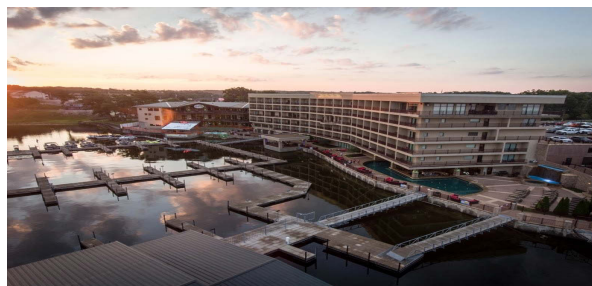

Training Session Overview

Crypto Crime Investigations (4 hours): Tom Albers, Kansas Gaming Commission, will provide an introductory course designed for patrol officers to familiarize themselves with cryptocurrency basics. Attendees will learn how to recognize potential crypto crimes, conduct initial investigations, and secure vital digital evidence – all while providing essential support to victims.

Financial Frauds (4 hours): Detective Michael Clinton is assigned to the Saint Louis Fusion Center (STLFC) as a Cyber Analyst. He has served as a law enforcement officer with the St. Louis County Police Department for 11 years. In addition to being assigned to the STLFC, he is a Federal Bureau of Investigation (FBI) Task Force Officer (TFO) assigned to the St. Louis Field Office Cyber Squad. Detective Clinton is a Certified Cryptocurrency Investigator and has established the Midwest Cryptocurrency Task Force to assist local, state, and federal law enforcement in investigating, prosecuting, and seizing cryptocurrency to disrupt criminal organizations. A goal of the Midwest Cryptocurrency Task Force is to provide education to law enforcement and the public on cryptocurrency crimes. He assisted in establishing a Cyber Response Team consisting of the STLFC, FBI – St. Louis Cyber, United States Secret Service (USSS) – St. Louis Cyber, and the Cybersecurity and Infrastructure Security Agency (CISA) to respond to cyber events in the St. Louis Region. Together these agencies coordinate their responses and share real time intelligence information to help prevent further attacks from occurring across the nation. Det. Clinton maintains cryptocurrency certifications from Blockchain Intelligence Group, Professional Law Enforcement Training, TRM Labs, Chainalysis, and the National Computer Forensics Institute where he also has proctored the course several times. Detective Clinton serves as the Chief of Staff to Operation Shamrock.

During this course, attendees will be able to identify the various free resources available to them via the Missouri Fusion Center's, Midwest Cryptocurrency Task Force, and Operation Shamrock and how to contact each organization to support their cases; list and describe the five pillars of Operation Shamrock and how they function in fighting Pig Butchering, Transnational Organized Crime, and the private/public partnerships that exist that power Operation Shamrock; be able to identify and list the area of responsibility for the Midwest Cryptocurrency Task Force by knowing the 14 states they support, capabilities of the task force, and how they can become a member of the task force; and be able to define Pig Butchering, the origin of it, the location of some of the larger criminal organizations, and their ties to human trafficking. They will be able to identify with satellite imagery what these facilities look like when they are purpose built for scamming American's and what Law Enforcement is doing to combat Pig Butchering.

Abuse, Neglect and Exploitation of the Elderly and Disabled (4 hours): Jerry Green, Chief of Special Investigations, Missouri Department of Health and Senior Services, will provide an insight to current trends they are seeing with respect to abuse, neglect and exploitation of the Elderly and Disabled. How are they reported, to whom, and what measures can be taken to educate and prevent this from happening to our loved ones, whether it occurs in the home or professional care environment (hospital, nursing homes, etc.)

Internet Safety and Child Exploitation (4 hours): Sergeant Brad Dumit, Kansas City (MO) PD, will provide a session on Internet safety training for officers to teach parents/community/grade school/middle school/high school on topics such as gaming safety, what to know and do regarding sextortion; Investigations 101 on internet crimes against children/where to go for help; and how Missouri is set up to investigate these crimes (ICAC, FBI, HSI, Local agencies).

Emergency Management and Crime Prevention/Community Policing (4 hours): Anne Peolzl, Emergency Management Director, Clay County Sheriff's Office, will provide instruction on what is "Emergency Management?" How does it tie into policing, especially community policing; how to educate the public on what to expect in the event of a major incident; and how can we work together for the good of the communities we serve.
